### The National Problem

- The U.S. has the highest incarceration rate in the world with nearly **2 million** people in correctional facilities
- Jails are the front door to incarceration with over 10 million admissions annually
- Most people in jails are not yet convicted



## Jail has grown while crime has fallen

The ACJ opened in 1995 at the height of crime. Since then, crime dropped but the jail population grew significantly until 2010.

The jail population has been on a downward trend since 2010 but has not kept pace with the crime rate.

## Why reduce the Allegheny Jail Population?



### CAN DECREASE PUBLIC SAFETY

Holding low-risk defendants in jail while awaiting trial (even for just 2-3 days) has been found to *increase* the likelihood that they will commit new crimes in the future.



### HIGH COST TO TAXPAYERS

The county spends 32% of its direct expenditures on criminal justice including \$91 million annually on the jail.



## DISRUPTS COMMUNITIES

The affects of incarceration extend beyond the person who is in jail to families, employers, and communities.



#### DISPARATE IMPACT

Despite making up only 13% of the local population, African Americans make up 67% of the jail population.

Roughly **75%** of the jail population has a mental health or substance abuse issue.

## Allegheny County's SJC Strategies

The average daily population of the jail is a function of **admission rate** and **length of stay**.



## Allegheny County's SJC Strategies



#### **CRISIS RESPONSE**

DHS, 911, providers, and law enforcement develop ways to get people in crisis help sooner and avoid criminal justice involvement.



## REDUCE THE NUMBER AND LENGTH OF DETAINERS

Manage detainer population through policy and detainer workgroup and resolve probation violations and new charges together.



## REDUCE BOOKINGS AT FIRST APPEARANCE

Provide representation at first appearance, implement a revalidated Pretrial assessment



#### **JAIL REDESIGN**

Obtain community and stakeholder input to develop a new design for the physical structure of the jail to increase safety, improve rehabilitation, and reflect a smaller jail population.



#### **EXPEDITE COURT PROCESSING**

Reduce the amount of time people spend awaiting trial by moving two separate hearings to one day and shifting timeline for preparatory work



### CRISIS RESPONSE

- ✓ Crisis Response Stakeholder Group convened
- ✓ Recommendations and action plan created Implementing action plan
  - Improving response from central crisis numbers
  - Expanding mobile response options
  - Developing peer-operated respite centers
  - Supporting LEAD pilots



## REDUCING BOOKINGS AT FIRST APPEARANCE

- ✓ Pretrial assessment made available to all MDJs
- ✓ Revalidated local pretrial assessment and redesigned report implemented
- ✓ Pretrial qualification for PD instituted at preliminary arraignment
- ✓ PD representation at evening and overnight preliminary arraignments reduced use of monetary bond by 39%



## **EXPEDITING COURT PROCESSING**



Formal arraignment continuances lowered from 44% to average of 21%

Proposal to combine formal arraignment and pretrial conference is in planning

Eliminates one opportunity for FTA

Reduces time between hearings

Offers opportunity for meaningful hearing and option resolve the case



## REDUCING THE NUMBER AND LENGTH OF DETAINERS

- ✓ Detainer population lowered from 1,060 to 630
- ✓ Collaborative detainer workgroup created for complex detained cases
- ✓ Early probation termination policy created and roughly 70% of motions granted
- ✓ Early probation violation policy (EPV) policy created and nearly 500 early probation violation hearings were held saving an average of 84 days in jail per person

Solicitation released for consultant to lead stakeholder engagement and design process

Next steps will be engagement process and generation of design options

## Racial Equity and Community Engagement Work

Building a shared understanding of racial equity through training

Partnering on research studies


Utilizing technical assistance to develop internal strategies through a Racial Equity Working Group

Feedback sought through listening sessions

Community Advisory Committee created to learn about strategies and provide recommendations

Grant funds will be distributed to community-based projects

## Jail Population Trend



The jail population is down 36% from the baseline population

Rearrest rates of people released during the grant period are lower than rates of people released prior to the grant

Baseline period: 11/1/2017 – 4/30/2018
