What has the impact of Title IX been on college sports?

- POSITIVE (mostly)
- Historical: adopted in 1972 and since then there has been better funding, opportunities for women to participate in college sports and access to sports through college
- Why was it so bad before?
- Major improvement for terms of people who work in sports (think college athletics administrators, media, ancillary sports industries)
- What do we still need to do to help female athletes?

WISCONSIN

How have the increase in college sports impact leadership positions/roles in college sports and beyond?

 Title IX has helped grow the number of women coaching in college sports, administrators,

and leaders in sports

- Title IX has helped with compensation and growing opportunities
- However, some head coaching positions

of female sports has become very lucrative so men have been taking on these head coaching roles.

- More women than ever before working in football front office and coaching roles too
- More women referees as well

Why are there still so few female ADs and Commissioners in college sports?

- Stigma
- Perception
- Old school mentality
- There are more female ADs in Division II and III than Division I.
 There is some continued growth of female leaders but at the top levels of Division I (power 5) they have remained fairly stagnant.

How do we reconcile the discrepancy of revenue sharing with women athletes in the new collegiate revenue sharing model? How does Title IX apply to the

House case settlement?



- It is unknown for sure how Title IX will apply to the revenue sharing model however many schools believe the revenues can be shared in the same percentage that they are earned and are not subject to Title IX.
- Institutions still have to comply with Title IX in participation opportunities, scholarships and experiences. Therefore you are seeing some schools adding additional scholarships to female sports to make up for the lack of revenue sharing funds they are providing their female student-athletes.
